KEYNOTE ADDRESS

"The Mental Health Court Model"

Judge Stephen Manley is a graduate of Stanford Law School. He is presently a Superior Court Judge in Santa Clara County, California and has served on the Bench for nearly 30 years. His current assignment is Supervising Judge for all felony drug cases and mental health cases in San Jose, California. He developed the court implementation plan for Proposition 36, and he oversees that implementation, which involves nine judges who supervise over 5,000 defendants in treatment through a court managed "collaborative system".

In 1996, he founded the Santa Clara County Drug Court; in 1998, he founded the Mental Health Court, which is now the largest mental health treatment court in the United States. These courts provide treatment and supervision for 1,350 defendants. The unique programs combine court oversight and direct mental health services, psychiatric services and alcohol and drug services physically located within the court facility.

Judge Manley has drafted a bill, currently pending in the Legislature, which would establish Mental Health Courts in California. He has also proposed policies which, if adopted by the Commission overseeing the implementation of the Mental Health Services Act, will require all County plans to include services for court clients with co-occurring disorders. He advocates across the State for the development of these courts, and he assists other jurisdictions in implementing them.

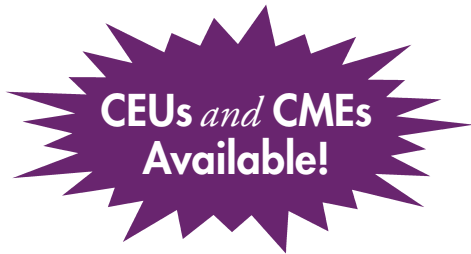
